It is agreed that we are only acting as your agent and that you will reimburse, indemnify, and hold us harmless from the payment of any duties, additional duties, losses or damages imposed by any law or regulations of any government agency in connection with the shipment of the goods. It is further agreed that we are not responsible for shortages or losses of goods carried by common or private cartage nor are allowances allowed of duty or charges on any portion of lost merchandise.
